August ICEL Luncheon Re-cap "In The Trenches"

At our August meeting we heard from our own Penny Williams and Janae Jeffs, CCE. Penny is employed by Midwest Floor Coverings, a wholesale flooring and building products distributor. Janae is employed by Muir Enterprises, a premier perishable food distributor in the Intermountain West.

Penny spoke of her long journey down the road of credit. She spoke of her first days as a credit manager and one of her challenges of putting a very large, but very delinquent, account on credit hold. She was told by her customer that if she did not release the hold her company would lose their business. As a new credit manager her thoughts were of a lost account. As it turned out, Penny was able to find a payment plan that was acceptable to both parties and ended up not losing the account.

Penny went on to say that in the following years she depended on NACM and ICEL to teach her the finer points of credit and to give her the confidence that her decisions were based on good credit management. In June of 2009 Penny attended NACM National Credit Congress in Orlando. She spoke of the great speakers, educational classes, and all of the networking that was available. Penny encouraged all of us to start working on our bosses to let us attend Credit Congress next year which is in Las Vegas and to also remember that there are scholarships available from ICEL.

Janae began speaking of Frederick Winslow Taylor whose work is most remembered for developing a time and motion study and the one best way to get things done.

Janae next spoke of Frank and Lillian Gilbreth—one of the great husband-and-wife teams of science and engineering. Frank Gilbreth's well-known work in improving brick-laying in the construction trade is a good example of his approach. He observed that workers developed their own way of working and that no two used the same method. In studying bricklayers he noted that individuals did not always use the same motions in the course of their work. These observations led him to seek the "one best way" to perform tasks.

Janae explored some of the credit trenches we all face—organization and prioritizing. She challenged us to go back to our office and find ways to be more efficient. Janae gave some basic examples such as printing several items at once and going to get them from the printer at the same time or going to your mail room once with several pieces. She encouraged us to use the "one touch" paper theory.
